**All drivers are responsible for paying for their own tires. Drivers must pay delivering supply point at time of transaction by cash or credit card.**

2. Visit any Goodyear authorized supply point for appointment.
3. Present this program letter to delivering supply-point to receive special pricing.
4. Independent Contractor pays delivering supply point for tire(s) and service work performed.
5. Note: No taxes or services are included in pricing and are always extra cost, if required.

This Program cannot be used in conjunction with any other Programs, discounts, coupons for special deals. The Program applies only to purchases from Goodyear company owned stores and participating dealers and is a pricing program only. Although participating dealers may offer the pricing described under the Program, sales are by the participating dealer rather than through Goodyear.
